Identification: Each work must have **two** 3 x 5 cards, attached separately to the upper left back corner showing artist's name, address, phone number, email, title of work, size and price. Information must match entry form.

Requirements: **All entries must comply with MGAL Exhibition Rules listed in the MGAL Yearbook and on the website. Maximum frame size 45"x 45"**. No nudity in artwork allowed. No work will be allowed to leave before the exhibition closes.

Sales: POTS does not require a commission on sales. **All exhibited work may be for sale.**

Awards: Best of Show, 2nd Place, 3rd Place, two Honorable Mention and other awards as available.
